Climate change disclosure and socially responsible investment strategies

Many asset owners, including pension funds and insurance companies, index providers, rating agencies and asset managers, are starting to take even greater into account the integration of environmental, social and governance issues (ESG) into responsible investment strategies. Such organizations are focusing their attention on companies whose management involves a positive impact on climate change currently under way that adopt decarbonisation strategies with a special focus on renewable energy and reduction of high greenhouse gas emissions (GHG).
