

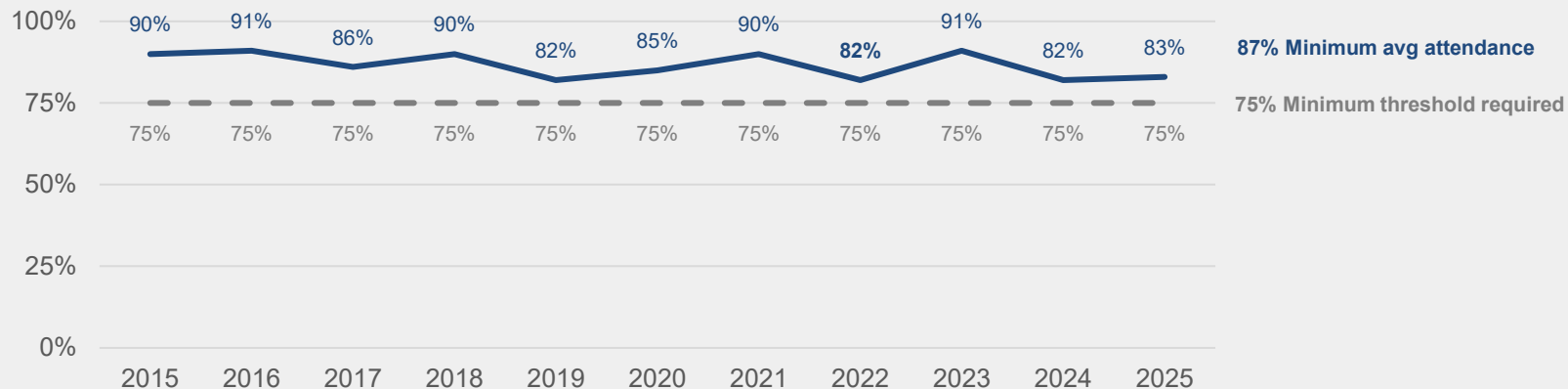

2025 Board member attendance vs minimum threshold required



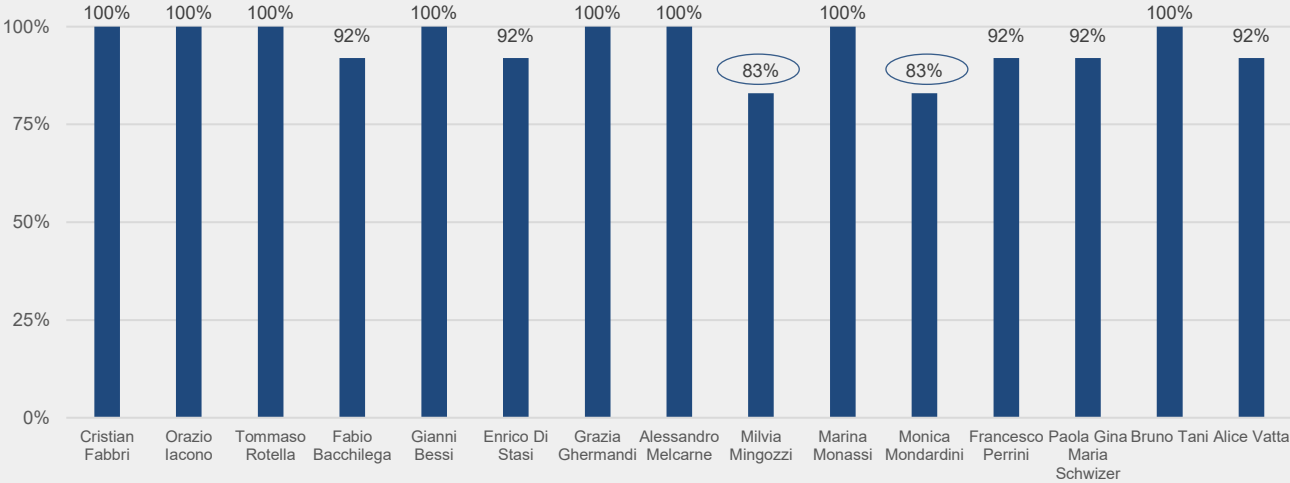

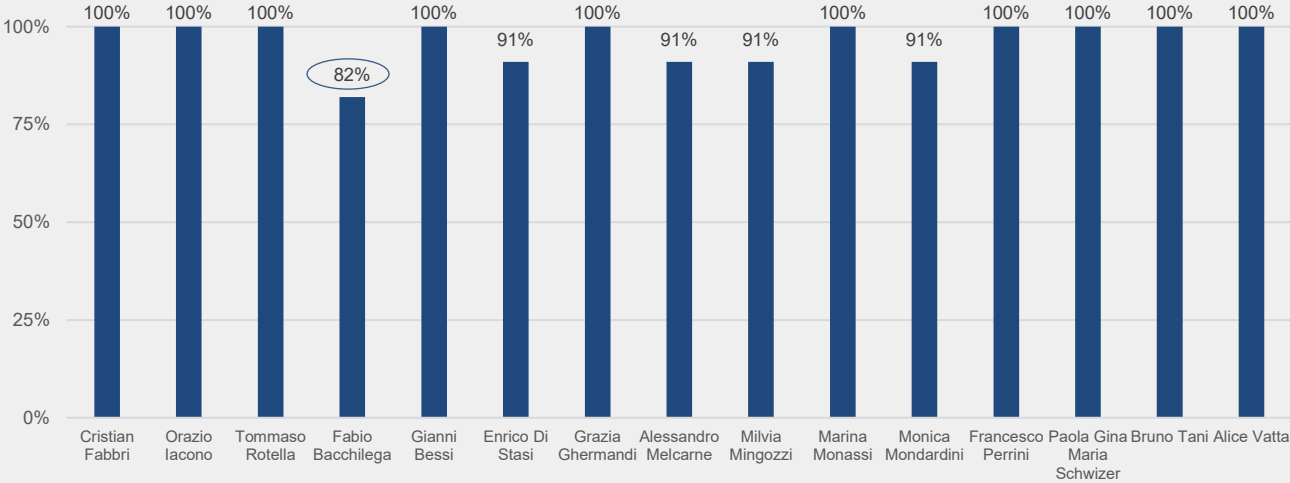

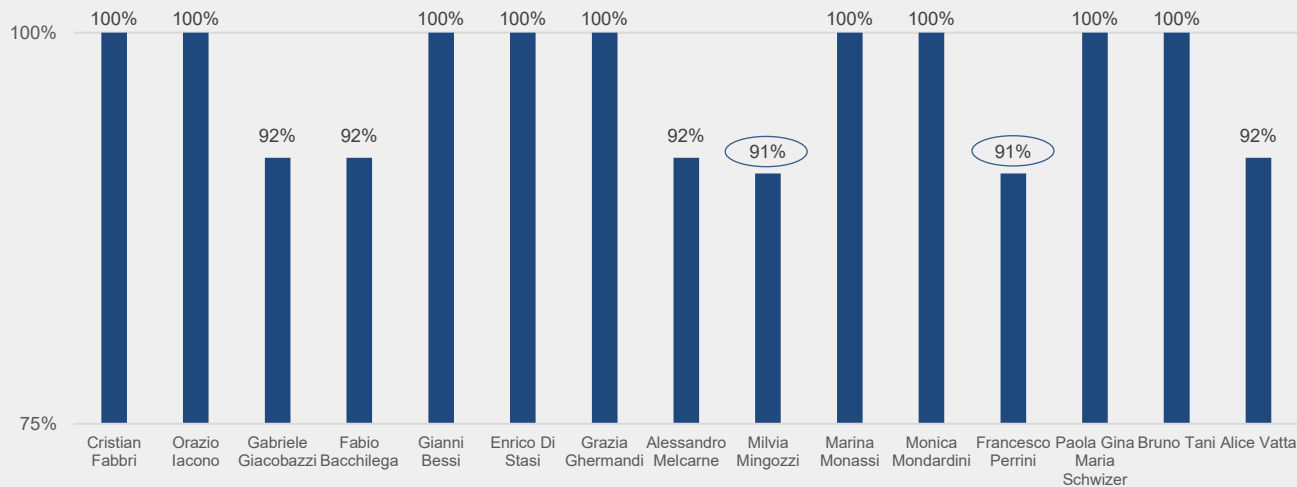

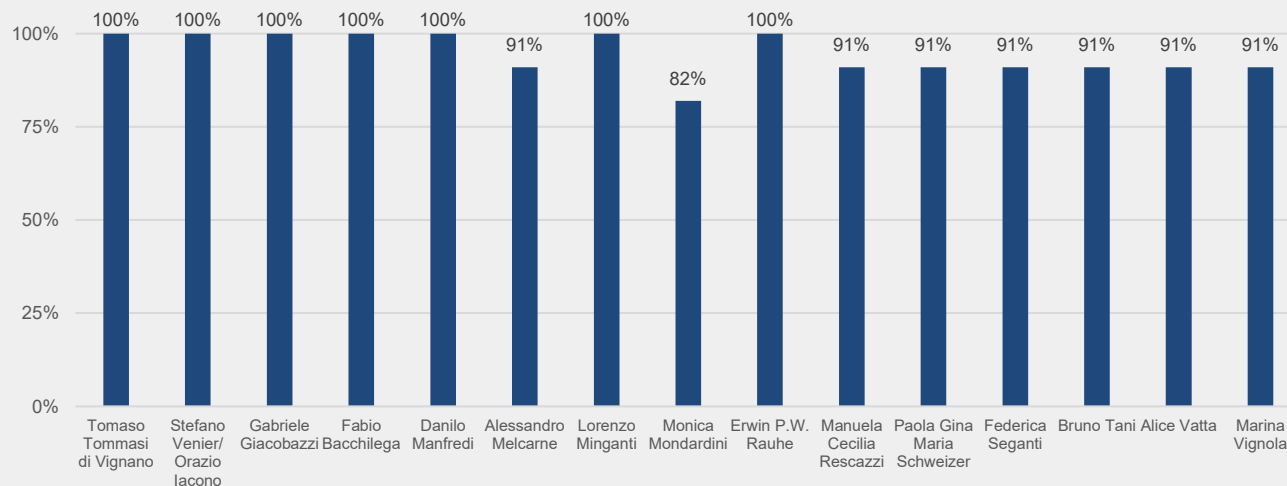

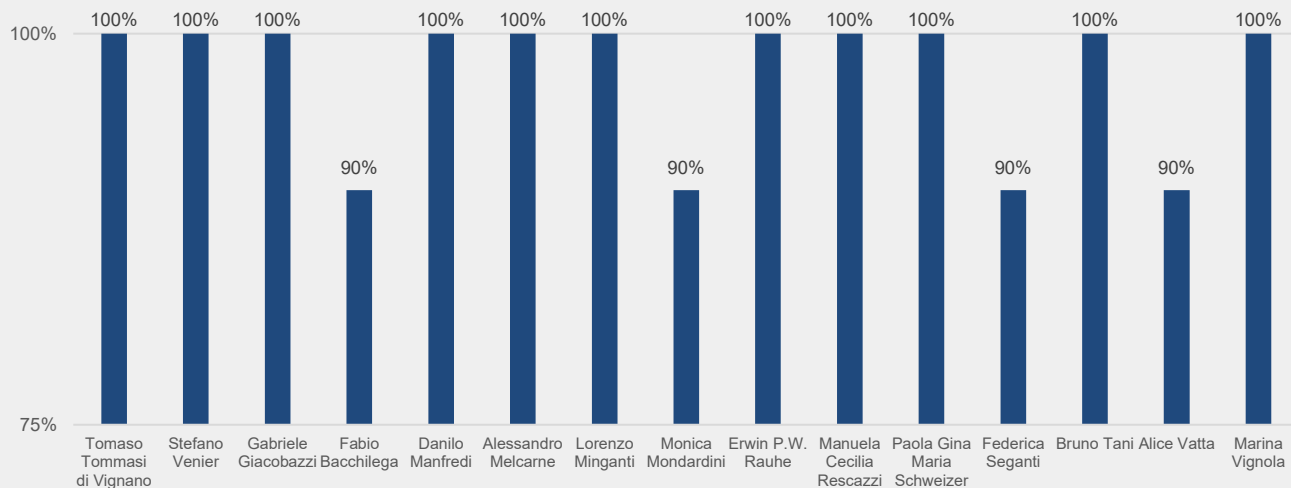

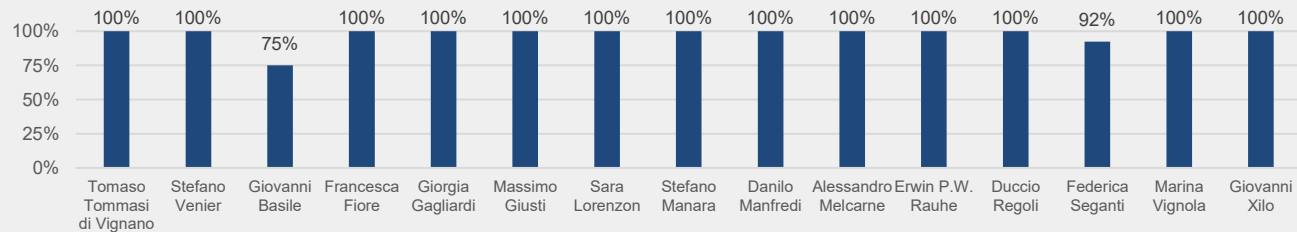

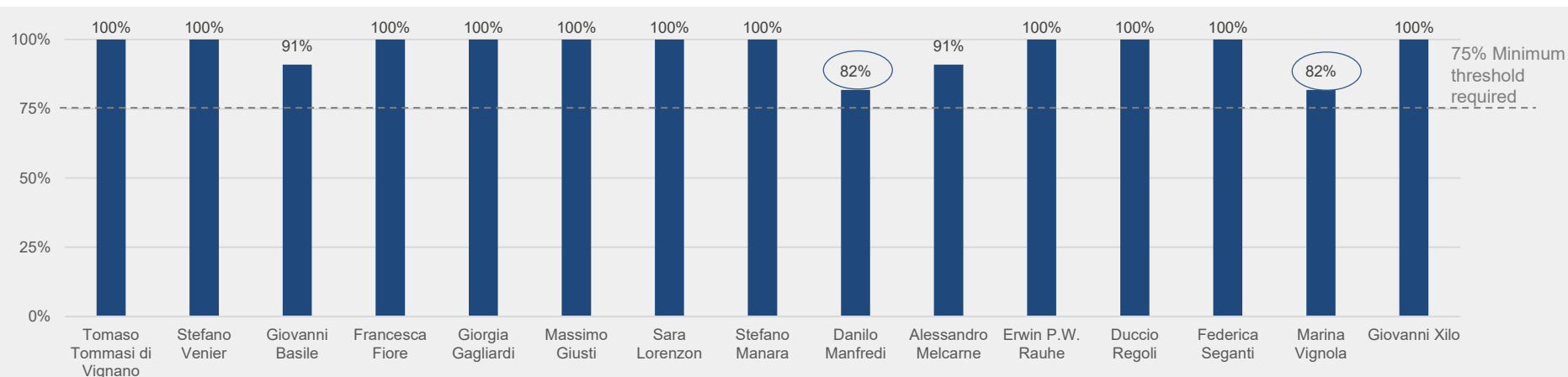

2019 Board members attendance vs minimum threshold required



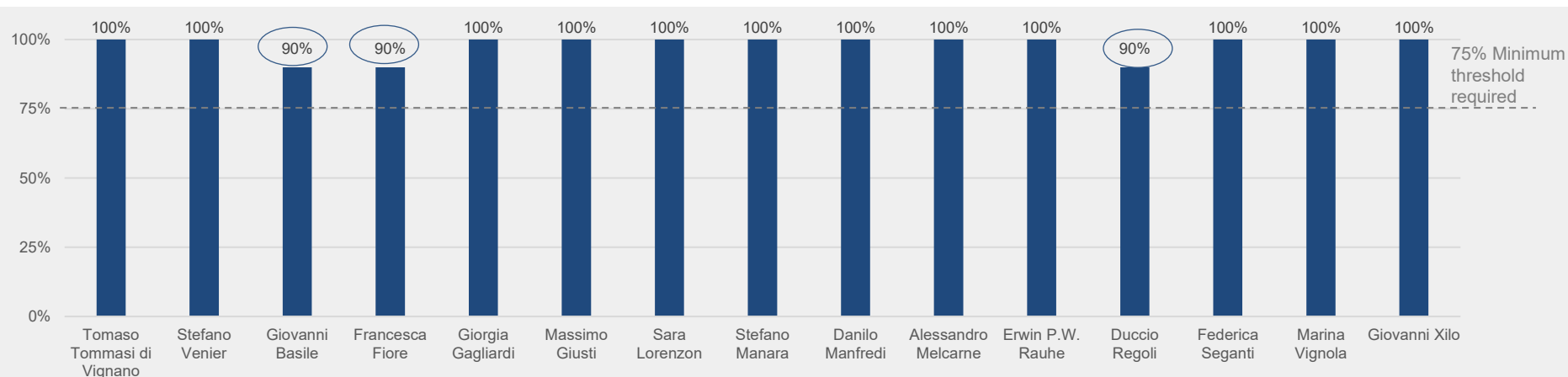

2018 Board members attendance vs minimum threshold required



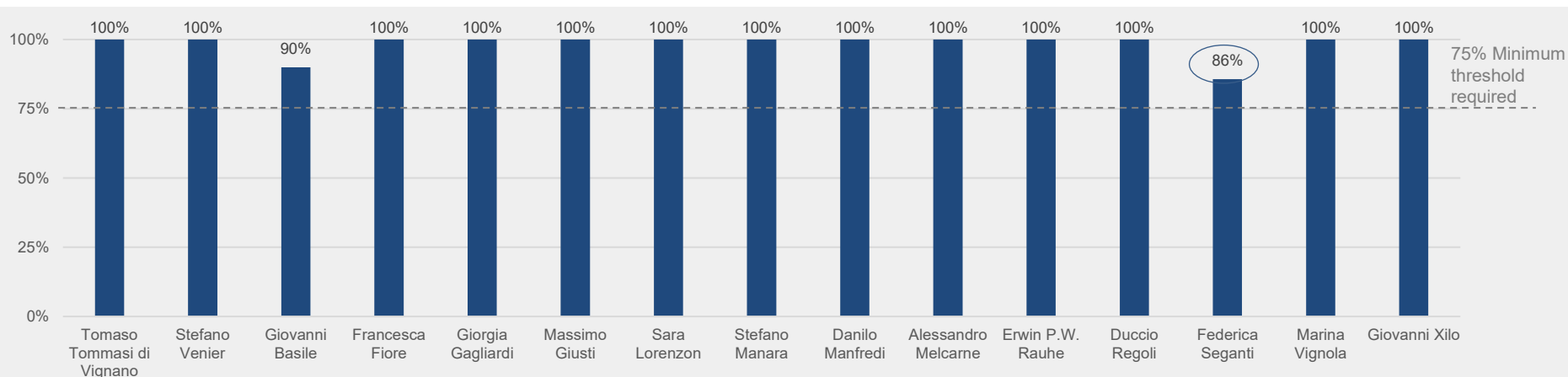

2017 Board members attendance vs minimum threshold required



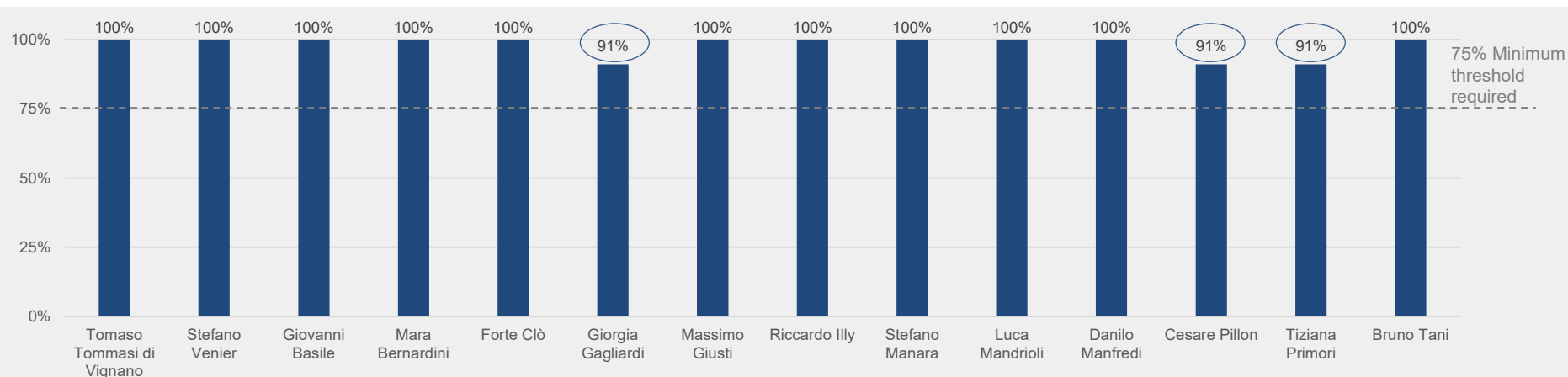

2016 Board members attendance vs minimum threshold required



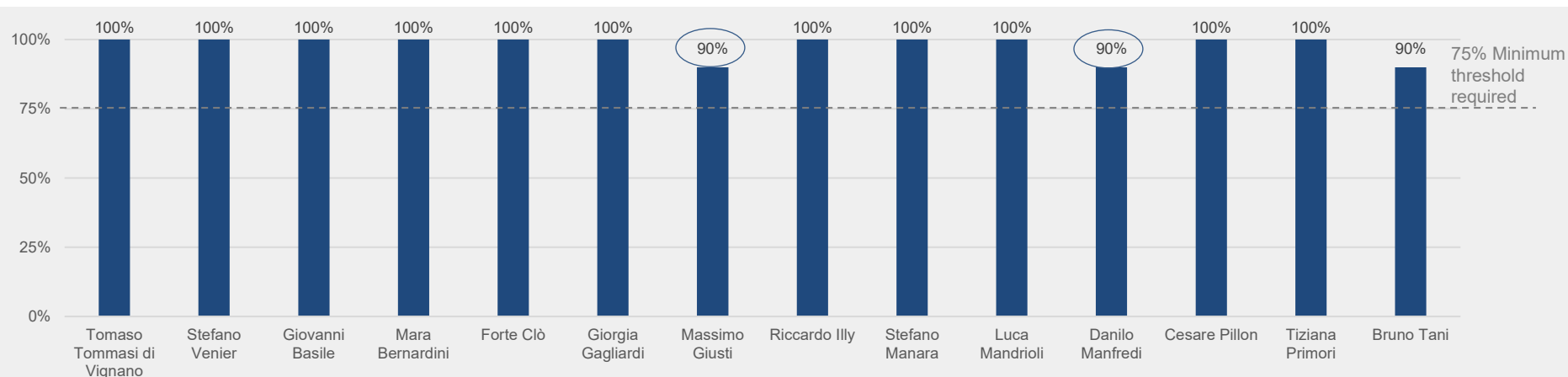
